

How to use the ONCOCHART Clinical Quality Measures/PQRS calculator

The ONCOCHART Clinical Quality Measures (CQM)/PQRS calculator is designed to help you keep track of your facility's progress and/or compliance. It will automatically calculate all the numerators, denominators and exclusions with the click of a button! If you prefer, you can calculate these values for each individual measure separately.

The numerator, denominator and exclusion values are based on the quality data you've entered into ONCOCHART. For a list of our current Clinical Quality Measures/PQRS, you can visit our <u>Meaningful Use website</u>. The instructions below should help you better understand this tool's function and how to use it.

- 1. View Results
 - A. Numerator number of patients for which the measure has been satisfied
 - B. Denominator number of patients who are eligible for the measure
 - C. Denominator Exclusions
 - D. Calculate/Re-Calculate individual measure

Access an existing CQM Calculator report

- 1. Utilities > Utilities > Clinical Quality Measure Calculations
- 2. Highlight your entry then click *Edit Selected* to view and/or recalculate this report.
- 3. Click *View Report* to generate a single report that will display your last saved progress.
- 4. Click *Completed* to hide the entry on the form. Click *View Completed* to display all entries.

How to Generate a Clinical Quality Measures/PQRS (QRDA) XML Category III file

Depending on your method of Clinical Quality Measure/PQRS attestation, you may need to submit your CQM/PQRS in an electronic format.

1. Once you've calculated your CQMs, click Save.



2. Click Submit. This will open Windows explorer, which will allow you to save the QRDA/XML file to a location on your computer. Choose your desired location and save the file.



3. From here, you'll need to follow the submission instructions on the <u>PQRS Portal</u>.



Notes

- Clicking on the *Edit Selected* button, rather than *Add New* will allow you to view an existing CQM calculations report
- An existing CQM calculations report is a representation of the last saved state of your data. When opening an existing CQM calculations report be sure to click *Calculate All*, so that you will have the most recent data in the calculator.
- Before generating the QRDA III/XML file, make sure the provider's NPI and Tax ID Number **without** dashes and spaces, for which the provider receives payment, are populated in the ONCOCHART security form.
- If you're going to submit your CQMs/PQRS electronically via the PQRS portal, choose *PQRS Meaningful Use Individual*. Otherwise, choose the other option.
